With reference to the subject cited above, it is to inform you that, as per the Ministry of Home Affairs letter dated 29.08.2020 regarding Unlock 4, Para. 1 (i) c. Students of Classes 9 to 12 may be permitted to visit their schools, in areas outside the containment zones only, on Voluntary basis, for taking guidance from their teachers. This will be subject to written consent of their parents/guardians and will be permitted with effect from 21<sup>st</sup> September 2020 for which, SOP will be issued by MoHFW.


**SOP issued by MoHFW, regarding partial opening of Vidyalaya for Classes 9 to 12.**  
it is requested to follow the instructions provided below:-

- 1) It is mandatory to provide written consent while sending your ward to the Vidyalaya. Copy of consent letter is enclosed.
- 2) No student shall be allowed in the Vidyalaya premises without taking prior permission of Class teachers as well as principal.
- 3) Physical distancing of at least 6 feet to be followed as far as feasible.
- 4) Use of face covers/masks to be made mandatory.
- 5) Frequent hand washing with soap (for at least 40-60 seconds) even when hands are not visibly dirty. Use of alcohol-based hand sanitizers (for at least 20 seconds) can be done wherever feasible.
- 6) Respiratory etiquettes to be strictly followed. This involves strict practice of covering one's mouth and nose while coughing/sneezing with a tissue/handkerchief/flexed elbow and disposing off used tissues properly.
- 7) Self-monitoring of health by all and reporting any illness at the earliest.
- 8) Spitting shall be strictly prohibited.
- 9) Installation & use of Aarogya Setu App may be advised wherever feasible.
